

**SLAVE LAKE AIRPORT SERVICES COMMISSION
BYLAW #03-2020**

BEING A BYLAW OF THE BOARD OF DIRECTORS OF THE SLAVE LAKE AIRPORT SERVICES COMMISSION TO GOVERN THE FEES TO BE CHARGED BY THE COMMISSION FOR SERVICES PROVIDED.

WHEREAS the Slave Lake Airport Services Commission has been established by the Lieutenant Governor in Council by Alberta Regulations 267/98 and made pursuant to the Municipal Government Act,; and

WHEREAS the Board of Directors of the Slave Lake Airport Services Commission wishes to make a Bylaw pursuant to section 602.07(3) of the Municipal Government Act, governing the fees to be charged by the Commission for services provided to its customers or to any class of its customers;

NOW THEREFORE BE IT ENACTED, as a Bylaw of the Board of Directors of the Slave Lake Airport Services Commission as follows:

1. DEFINITIONS

- a) "Act" shall mean the Municipal Government Act, R.S.A. 2000, c. M-26 as amended from time to time.
- b) "Board" shall mean the Board of Directors of the Slave Lake Airport Services Commission as appointed from time to time.
- c) "Commission" shall mean the Slave Lake Airport Services Commission.
- d) "Director" shall mean the directors of the Slave Lake Airport Services Commission as appointed from time to time.
- e) "Member" or "Members" means the member municipal authorities as set out in the Regulation; and
- f) "Regulation" means Alberta Regulation No. 267/98.

2. FEES AND CHARGES

The fees charged by the Commission for Airport services shall be determined by the Board from time to time and the fees charged by the Commission to members and non-members shall not be less than the amount necessary to cover the estimated expenditures and expenses of the Commission less any grants, transfers from accumulated surplus funds or reserves or any other revenues.

Equipment Rental Rates, Service Charges Lease Rates, and Landing Fees shall be as set out in attached Schedule "A".


This bylaw shall come into force and effect on January 1st, 2020

Once maintenance operations have commenced, they will continue until the airport is in a condition that will not compromise the safety of aircraft using the runway, taxiways, or apron.
Aircraft Landing Fees	See Schedule "A" Page 3	<ul style="list-style-type: none"> Landing fees apply to all fixed wing and rotary wing aircraft which are registered to a business, company, corporation or flight school. Aircraft under 5,000 kg registered to an individual person are considered private use and exempt from landing fees Landing fees apply to all rotary wing flights except <i>on airport</i> hover taxi relocation flights. Landing fees do not apply to Touch and Go Landings. Maintenance and training flights are not exempt from landing fees.
